Town of McMillan Plan Commission 2022 Spring Newsletter

The Comprehensive Plan has now been finalized and approved by the Marathon County Board of Supervisors. The last time the plan was updated was 2005. We would like to thank previous Town Boards and Plan Commissions for their work on previously existing plans, providing the foundation from which we have built the new and current plan. We also couldn't have done this without the help and guidance of the Marathon County Conservation, Planning and Zoning department (CPZ). Laurie Miskimins is the CPZ director. Under her is Conservation Analyst Kirk Langfoss, Zoning Analyst Dominique Swangstu, and Planning Analyst Jeff Pritchard. Also involved was Darryl Landeau from the North Central Wisconsin Regional Planning Commission. We used all of these resource people to update the Comprehensive Plan. Once the Comprehensive Plan was updated, it was then submitted to the Town Board for approval. From there it went to the County Environmental Resources Committee and lastly to the Marathon County Board of Supervisors for final approval. There are many layers of government looking at this document.

We are also pleased, that with the update, a problem was solved for an individual landowner. An individual bought 20 acres of land through a realtor and thought, or assumed, or was led to believe that he could build a home on it. However, after the transaction was made and the person went to the County for a building permit, the individual discovered he couldn't build because the parcel was identified as an outlot and was also zoned Farmland Preservation. So, he had two problems. How could this happen? Buyer beware. An outlot is a remnant or parcel of land left over after platting, which is intended as open space, for which no building permit shall be issued. If the parcel is zoned Farmland Preservation, you need 35 acres to be able to build a home. This individual could farm it, rent it to someone else to farm, or leave it idle, but he could not do that which he bought it for and that was to build a home. It was at this point that the person presented his situation to the Plan Commission. This is when the Plan Commission and Town Board were made aware our Comprehensive Plan had not been updated at the County level since 2005. It was then that discussions were initiated with North Central Wisconsin Regional Planning Commission, to help us follow the process to start the update.

This Plan Commission functions with an attitude of humility. Most citizens don't like the feeling of being ruled over no matter how well intended. How much freedom do you allow property owners to do what they want with their property and when does government overrule their desire? Our objective is to apply ordinances even handedly. We do seriously look at every request. We always try to listen to the public concerns. There are County Ordinances that we have to follow. Lastly, not every land transaction comes before us. Some things bypass the Plan Commission and go directly to the County and we hear about it after the fact. If it isn't presented to the Plan Commission first, there sometimes isn't much that we can do about it later.

In Person Absentee Voting

If you are interested in voting In Person Absentee, please contact the Clerk's Office at 715-389-1338 or email townclerk@townofmcmillan.com This is available two weeks prior to an election.

Please keep in mind with recent court rulings the use of a Drop Box for absentee ballots returns is no longer available. If you've requested an absentee ballot by mail, please return the ballot by mail or bring the ballot to the Clerk's Office by appointment or bring to the Polling Place on Election Day. If anyone has any questions, please call the clerk.

Garbage & Recycling

Advanced Disposal was purchased by Waste Management, but other than the name change, not much has changed. The garbage collection fee for 2022 is \$19.50 (vs \$18.91 in 2021) per household for the 0.5 YD can. The monthly household total count has been running 770 to 772 pickups. This makes the monthly bill about \$15,000 for garbage. For the recycle collection, the 2022 fee is \$3.43 per household for the 0.5 YD can. Again, the count is typically 770 cans making the monthly fee about \$2,640 for McMillan, however the Recycling Board pays for the recycling costs of all 6 member townships on one bill. The Town of McMillan pays the Northwest Recycling Board twice a year for the recycling costs and Waste Management/Advance Disposal monthly for garbage collection.

Each household is allowed one container for recycling. Additional recycling containers can be obtained by each household but the additional container will cost \$20/year which is billed separately by the township. If Waste Management billed it you'd be paying more than \$20/month because they pay a third party to do their billing and must cover the overhead costs for each additional invoice mailed out. So if you do have a second recycling container, make sure to pay the extra fee that you receive from the township each year.

Each year there is a DNR Grant for recycling that the board applies for and receives. The grant total for the 6 townships for 2021 was \$16,117.19. This money is used to offset recycling costs and is distributed to the 6 townships based on population. McMillan's share is \$4,470.19 for 2021. For 2022, we won't find out the grant amount until at least April and the amount is divided by the number of applicants.

Make note that the Tire Recycling day for 2022 is on Saturday April 30, 2022 from 8am-3pm at Pankratz Trucking on Highway 10 near Nasonville Dairy southwest of Marshfield. If you have tires to drop off, make sure to get a red ID card from the town clerk's office as you must present this as proof you are a resident of the town. Each resident is allowed to drop off 8 car/truck tires (no rims) at no fee. Additional tires have a charge of \$4 per tire. All tires 10.0 x 22.5 or larger the fee will be \$10/tire, tractor tire fee is \$20/tire. Look for the annual tire collection add in the Hub City Times / Buyers Guide on April 20 and April 27.

The Garbage & Recycling schedule for 2022 is available at the town hall if you didn't receive one. Remember that recycling pickup is on Wednesday for those West of Galvin and Thursday for those East of Galvin.

Please secure your loads on your way to the drop-off site. **No Rims, No Commercial.**
This collection service is funded by the Townships of Cameron, Lincoln, Marshfield, McMillan, Richfield and Rock and is only available to the residents of the Townships listed.
Each residence is allowed to drop-off a total of 8 auto/light truck tires at no fee.
A fee of \$4.00 is charged for each auto/light truck tire that exceeds the 8 allowed.
All tires larger will be charged a fee of \$10 each. Tractor tires will be charged a fee of \$20 each.




From the Chief's Desk: Adam Knapp

Burning permits are required in DNR forest fire protection areas (see Map) to conduct burning legal materials when the ground is not completely covered in snow. DNR burning permits do not apply within incorporated cities and villages. These municipalities often can and do create their own burning permit requirements. In addition, some townships may choose to be much more restrictive than state law and may not allow burning at any time. Regardless of where you burn, it is up to you to check with your local municipality for their regulations, even if you have obtained a DNR burning permit.

The Town of McMillan is **not** part of the DNR's protection area for burning permits. The town ordinance is as follows:

295-25. Burning Permits

A. No person shall start or maintain any open burning without a burning permit issued by the Fire Chief or designee.



B. An outdoor campfire does not

require a permit, provided that the fire complies with all other applicable provisions of this article.

C. Any person responsible for burning leaves, brush, clean wood or other vegetative debris under § 295-20 of this article shall obtain a one-time burning permit before starting the fire.

D. When weather conditions warrant, the Fire Chief or the Department of Natural Resources may declare a burning moratorium on all open burning and temporarily suspend previously issued burning permits for open burning.

E. A burning permit issued under this section shall require compliance with all applicable provisions of this article

and any additional special restrictions deemed necessary to protect public health and safety.

F. Any violation of the conditions of a burning permit shall be deemed a violation of this article. Any violation of this article or the burning permit shall void the permit.
