The agent is sending us an estimate for additional Cyber Security coverage which would add to the policy coverage for third party suits in case of breach of information. Category expense totals are General Government \$137,965; Public Safety \$158,202; Public Works \$463,821.37; Culture, Rec & Education \$98,932; Conservation & Development \$4,000; Capitol Outlay \$40,000; and Debt Service \$32,343.22 Total expense \$935,263.59. Move \$40,000 from capital outlay to roads until all grant opportunities are exhausted. Motion Nowaczyk/Steines to approve a category budget with amendment and line-item detail to board on quarterly basis. Motion carried voice vote.
