K. Highway Building Bids -

Towne Construction Arpin – Bid of \$33,000.00 - \$23,000.00 down payment, \$10,000.00 when job is completed.

Stratford Building Supply – Bid of \$46,300.00 - \$10,000.00 down payment, \$36,300.00 when job is completed.

Motion was made by R. Wegner, seconded by R. Duerr to accept Stratford Building Supply bid of \$46,300.00 with down payment of \$10,000.00.

Discussion by board – Wegner – Stratford Building Supply bid is more complete.

Engel - \$13,000.00 difference between bids. Swenson – Not comfortable with project; doesn't meet long-term needs of the township. Wegner – Intent was to maintain "Cool" storage. Engel – What about cost of heating system? Should know cost before project is started. Stratford Building Supply representative Joe Burger stated bid is good for 10 days. Wegner – Will investigate cost of heating and electrical. Engel – Asked if heating needs to be bid out? Wegner – Amended his motion to hold the 2 bids until heating and electrical costs can be gotten and to place this item on the next meeting.

Motion by D. Swenson, seconded by G. Engel the No Weapons allowed signage township buildings. After much discussion G. Engel moved to give to Buildings Grounds Committee for recommendations to board. Seconded by R. Wegner.
