The department has two members who have completed the one-year probation successfully. The two individuals are Kyle Kilty and Mykayla Gerretsen.

The training for this upcoming month will be going to the Marshfield Fire Station to familiarize ourselves with the ambulance and where things are placed on it.

The department has formed a Rescue Three committee. The committee discussed the utilization needs of the rig. This committee has met and researched replacement vehicles for the current Rescue Three. Rod will update under old business on the agenda of the Town Board meeting.

EMS Update: The EMS group will start their refresher this week at the station. We will also be hosting Stratford and other members of the community who need the EMT/EMR refresher also.

Proposal for Surfacing Birch Street

- Whereas Town of McMillan has 17 roads already chip-sealed,
- Whereas Birch Street from County Hwy T to Day Road has been listed on the CIP as follows:
 - 2009 for upgrading
 - 2012 for hard-surfacing
 - 2015 for application of base layer (placed)
 - as well as many previous promises for paving of this road,
- Whereas Cayman and Gilead, already paved, are scheduled for blacktopping at a cost of \$137,200, as detailed in the minutes of the Town of McMillan Board Meeting dated Nov. 15, 2017,
- Whereas maintenance and repair of blacktop roads have the potential to be more costly to maintain than double chip-sealed roads,
- Whereas the citizens on Birch Street have procured an estimate of \$43,911 for double chip-sealing of Birch Street, understanding that prep work for chip-sealing of that road could be done by the current township equipment and personnel to ensure cost savings of the project, an estimate which would also have worked "within the budget of the General Transportation Aid and Shared Revenue Grant" as suggested as criteria for road improvement selection by Dave Swenson at the Town Board Meeting of Nov. 15, 2017,
- Whereas Drake Avenue, a majority agricultural road with 12 residences and 20 field-access driveways, is scheduled for blacktopping for 2 miles as listed in the CIP 2016-2021 document at a cost of \$420,000 in 2019 and \$420,000 in 2021,
- Whereas the said one mile of Birch Street, mainly residential with 14 private driveways and 5 field-access driveways and occasional agricultural traffic, provided the Town of McMillan \$40,057 according to the 2016 tax report compared to \$29,401 from the two miles of Drake Avenue scheduled to be blacktopped at significant cost to the township,
- Whereas Spruce and Willow, both dead-end roads, are listed in the CIP for chip-sealing in 2020, ahead of Birch Street,
- Whereas a grant was received for upgrading Birch Street in 2016, but assigned to another road
 project instead, and citizens at the Annual Budget Meeting on Dec. 22, 2016, voted to use
 highway funds budgeted and not used in 2016 for upgrading Birch Street,

the citizens of Birch Street from County Highway T to Day Road respectfully request that the Town of McMillan schedule this section of Birch Street for double chip-sealing in 2018 and request bids for this project in March of 2018.
