

#### FROM THE CHAIR:

Hello McMillan Residents.

I have been busy working on plans for Mann Street. We have finished replacing the culverts, and the town has approved a \$1,000,000.00 loan for this project. After the project is complete and paid for the State of Wisconsin will issue us the grant for approx. \$591,000.00. At that time, we can put the grant money toward the loan to lower the loan to a more realistic number. The bid from Earth, Inc. for the project is \$1,222,478.67 and has been approved. Construction will begin right after Labor Day, with a completion date of November 7th. The road will be closed to through traffic and open only to local traffic. If you live on Mann Street, please be prepared for some inconvenience during this time. The construction will be a total reconstruction, not just a quick fix.

Your complaints about the roads have been heard, Unfortunately, we can't do them all at the same time.

Currently, our Highway Committee is in the process of developing a Capital Improvement Plan for road upgrades. The committee is actively assessing the condition of roads, prioritizing those requiring immediate attention. This program aims to lay the groundwork for systematic road maintenance.

#### **GARBAGE AND RECYCLING REPORT:**

Greetings McMillan Township Residents!

The tire recycling event took place on Saturday, April 27, 2024 at Pankratz Trucking on Highway 10 West.

The hosts for this year's collection were the Townships of Cameron and Richfield. This year's totals were 39 tons, vs. 52 tons for 2023. This was mainly due to the fact that the Northwest Recycling Board did not take large tractor tires.

At the last meeting on May 29th, we received notice of the recycling grant to the Northwest Recycling Board of \$16,107.34. The grant, per Wisconsin STATUTES, are calculated on a per capita basis. A total of 213 responsible units applied for this grant. The total population of all those eligible applicants is \$4,072,336. Th legislature provided \$1 million for this program. So per capita rate is \$0.245 per person in eligible responsible units. (\$1,000,000 divided by population equals \$0.245 per person in eligible responsible units).

This grant and tax dollars from each township fund garbage and recycling costs.

Carts are to be placed on the edge of the road, NOT on the roadway or in the traffic lanes!
